**Whereas:** During that time Bob has faithfully served the citizens of Lee County; and

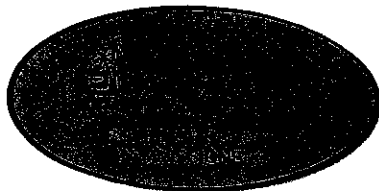
