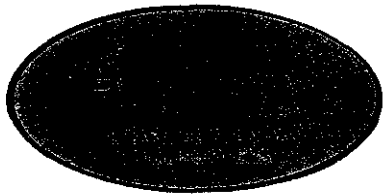
RESOLUTION
