8. Background:

City of Cape Coral requested DOT construct a north bound to west-bound left turn lane on Burnt Store Rd. at Embers. DOT designed the improvement with in-house staff and provided plans to construction. Construction is prepared to construct the project under our annual major intersection contract. The City has agreed to funding the improvement with surplus toll revenue thus providing a 60% (Lee County) 40% (Cape Coral) cost share for the construction portion. No right of way is necessary and all permits are in hand.
