The Lee County Sheriff's Office is requesting that the Lee County False Alarm Ordinance 03-09 be amended. The current ordinance requires alarm operators to annually apply and pay \$25.00 for an alarm permit. The proposed amendment to the ordinance will require alarm operators to apply and pay a "one-time" fee for an alarm permit. The permit will be valid indefinitely so long as the operator uses or controls the alarm system at the property in the alarm permit.


