Section 194.015, Fla. Stat., provides that three (3) members of the Board of County Commissioners will serve as representatives on the Value Adjustment Board. Two (2) School Board members comprise the remaining Board members. With the concurrence of the Property Appraiser's Office, it has been determined to hear Agricultural Classifications and Exemption denials prior to the normal hearing process for assessment petitions. An organizational meeting will need to be held in August, 2005 to cover new hearing procedure rules mandated by 2004 legislation and to refer all petitions to Special Magistrates for hearings.
