ACTION REQUESTED/PURPOSE: Award B-05-15 TICE COMMUNITY POOL AND FILTER RENOVATION for Parks & Recreation, to the lowest responsive/responsible bidder meeting all bidding requirements, Aquamarine Swimming Pool Company, for a total not-to-exceed amount of \$244,000.00, with a final project completion time of 120 calendar days. This project was anticipated and funds are available within the CIP budget.

WHAT ACTION ACCOMPLISHES: Provides Lee County with a Contractor to furnish all labor, materials and equipment for proper resurfacing of the pool, replacement of the pool deck, and installation of US Filters ES43-20-2 horizontal tank, sand filter system located at 4515 Glenwood Avenue, Fort Myers, Florida while conforming to all Lee County and Health Department codes.
