FOURTH AMENDMENT TO INTERIM DEVELOPMENT AGREEMENT

THIS AMENDMENT TO INTERIM DEVELOPMENT AGREEMENT (this "Amendment"), made and entered into as of August 9, 2005, by and between LEE COUNTY, FLORIDA, a political subdivision of the State of Florida (the "County") acting by and through its Board of County Commissioners, and COVANTA LEE, INC., a Florida corporation formerly known as Ogden Martin Systems of Lee, Inc. ("Covanta"), recites and provides as follows:

WHEREAS, the County and Covanta have entered into an Interim Development Agreement, dated as of September 28, 2004 (the "Interim Development Agreement"), as amended on December 20, 2004, as further amended pursuant to a Memorandum of Understanding between the County and Covanta dated as of January 18, 2005, and as further amended by a Second Amendment To Interim Development Agreement dated as of March 22, 2005 and a Third Amendment To Interim Development Agreement dated as of May 17, 2005; and

WHEREAS, the County and Covanta desire to further amend the Interim Development Agreement in accordance with the terms set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants, agreements and promises hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

- 1. Amendments. The Interim Development Agreement is hereby further amended as follows:
 - (A) In Paragraph 5(B), first sentence, strike the date "August 9, 2005" and insert in lieu thereof "September 22, 2005".
 - (B) In Exhibit D; Paragraph 3;

in the first paragraph, third sentence,

strike the date "August 31, 2005" and insert in lieu thereof "September 30, 2005";

in the chart with the headings "Date of Cancellation Notice Issued to Martin" and "Termination Fee (Stated in EURO's)" add the following at the end of the chart:

"September 1, 2005

through

September 30, 2005

€2,500,000.-

2. Effectiveness. All terms and conditions of the Interim Development Agreement, except as expressly amended herein, shall remain in full force and effect.

3. **Counterparts**. This Amendment may be executed in one or more counterparts, each of which will be deemed to be an original and all of which, when taken together, will be deemed to constitute one and the same Amendment.
