1. ACTION REQUESTED/PURPOSE:

Approve listing of nine (9) Mandatory Garbage Hardship Payment Deferral requests for Fiscal Year 05/06, October 1, 2005 through September 30, 2006. Approved listing will be submitted to the Property Appraiser for proper notation on the solid waste roll, and the Solid Waste Division will record a lien against the applicant's property.

9. Background:

On June 11, 1986, the Board passed the Mandatory Garbage Ordinance 86-14. On October 11, 1995, the Board amended the mandatory Garbage Ordinance by approving Ordinance 95-19. Section 6.7a provides a specific mechanism for deferring solid waste assessment payments given that the residential property owners meet certain conditions.

Included with Administrative Code AC-10-2 are provisions for Hardship Payment Deferrals. The purpose of a Hardship Payment Deferral is to allow a lien to be placed against the applicant's property until yearly garbage service fees can be made. Eligibility for this deferral is determined according to the Administrative Code.
