**AMENDMENT NUMBER 2
TO THE AGREEMENT BETWEEN LEE COUNTY AND THE LEE COUNTY SHERIFF
FOR ENFORCEMENT OF ENVIRONMENTAL CRIMES**

WHEREAS, the Lee County Board of County Commissioners (the "County") and the Lee County Sheriff (the "Sheriff") entered into an Agreement on September 9, 1999 that establishes a cooperative relationship between the Parties for the purpose of investigating environmental crimes particularly regarding illegal dumping and littering on County rights-of-way; and

WHEREAS, on the 3rd day of September, 2002, the Parties approved Amendment No. 1 to this Agreement; and

WHEREAS, the County and the Sheriff wish to continue this Agreement for one additional year with the duties and responsibilities of both Parties unchanged;

NOW THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED by the and between the Parties that the following changes to the Agreement are hereby made:

- A. SECTION C, Part e: Replace in its entirety with the following: The term of this Agreement shall be from September 9, 1999 through September 30, 2005.
- B. EXHIBIT A, Part 2 of 2: Replace in its entirety with the attached "Exhibit A (Amendment No. 2)"
