9. Background:

The Lee/Hendry County Regional Disposal Facility is a multi-phase facility intended to meet current and future County refuse disposal needs. Portions of the Landfill were constructed in 1996/97 and the County began operations at the landfill in late 2002. The BOCC approved Supplemental Agreement No. 6 in September 2001 (Bluesheet No.20010967-DSW) in the amount of \$328,550.00 for design and construction services associated with the landfill permitting and operation including the north Leachate Storage Pond, revised operations and maintenance facilities, revised leachate treatment system design and pilot testing. The BOCC approved Supplemental Agreement No. 9 in April 2003 (Bluesheet No. 20030518) in the amount of \$533,300 for design and construction services associated with a 25-acre landfill expansion including design, permitting, bidding assistance, and services during construction. The BOCC approved change order no. 10 on 11/16/04 (BS No. 20041470) for the design of a new clarifier, Final LF Cover Design, Fl Bldg Code changes, new fuel station, and financial assurance submittals, etc.

This change order is required for additional construction oversight services not included in the original Supplemental Agreement No. 6, including additional bidding oversight for two liner construction projects, additional shop drawing review, and extended construction duration for the leachate treatment system and the larger LF expansion footprint requiring additional construction quality assurance monitoring and review. Technical services and oversight will also be provided during operation of the Leachate Trtmt. Equipment.

Additional capital funds are also requested for the purchase of additional water testing (lab) equipment, landfill equip., and waste water handling equipment

> Request for Additional Services (Change Order) Lee/Hendry County Regional Disposal Facility Supplemental Agreement No. 6

Dear Mr. Sampson:

During the construction of the UF/RO Facility and the Phase 2 Landfill Expansion, additional services have been provided by Hazen and Sawyer, in a number of different areas, resulting in our need to request additional compensation. The key areas of additional work include:

- 1) UF/RO Facility Construction Submittal Review, Coordination and Startup
- 2) UF/RO Operations
- 3) Phase 2 Landfill Expansion Construction Related Services
- 4) Landfill Groundwater Mapping

Overview of Additional Services

- 1) UF/RO Facility Construction
 - a. Submittal Review

Our scope of services included review of Contractor submittals for schedules, equipment and installation for the numerous components to be incorporated into the UF/RO Facility. We reviewed submittals provided first by Lodge Construction beginning in late 2003 and then by Wright Construction from mid 2004 through the present time. A large number of submittals had to be reviewed several time to assure that comments were properly incorporated by the Construction Manager and their subcontractors and suppliers. This process required significantly more effort than could have been anticipated by Hazen and Sawyer or Lee County. This important review process is expected to continue until facility startup in July, 2005.

b. Coordination and Startup

In our original scope, and in the original Construction Manager contract, the construction was scheduled for completion in six months, or the middle of 2004. Under the current Construction Manager, the completion of the project is expected in July 2005. Hazen and Sawyer has spent considerable engineering resources to coordinate the activities of the Construction Manager, their subcontractors and suppliers since early 2004. We have also expended a considerable amount of time and expenses coordinating directly with suppliers and subcontractors. This work, which generally falls under the responsibility of the Construction Manager is considered by both Lee County and Hazen and Sawyer as critical to the successful completion of the project, but was not anticipated at the time our original scope was developed.

Hazen and Sawyer anticipates that significant engineering hours will be required during the UF/RO startup process, which is anticipated to take three to four weeks to complete. According to the current schedule, UF/RO startup will be completed in July, 2005.

2) UF/RO Operations Consulting

Hazen and Sawyer proposes to assist the County and the Construction Manager in evaluating the UF/RO during its first year of operations. The goals of these engineering services are to review facility operations data, to assess performance and to recommend adjustments to improve the efficiency of operations. In addition, Hazen and Sawyer will identify nonconforming equipment or components and provide Lee County personnel with assistance on equipment warranty issues.

3) Phase 2 Landfill Construction

a. Expansion Area CQA

In our original 2003 scope of services, we assumed that the Phase 2 expansion area would be 12 to 15-acres in size and require approximately 18 weeks to construct. Increasing quantities of refuse disposed in Lee County and overall efficiency in construction and operations resulted in a Phase 2 expansion area of 25-acres (Cell 5 and Cells 7 through 10). This expansion was permitted by the FDEP. Although this did not significantly impact the design or permitting phase of the project, it had significant impact on the construction related cost. Cell 5 was completed in December 2004 (and is now in operation) and construction of Cells 7-10 is currently underway. The Contractor has been issued an extension in the construction schedule and construction is expected to be complete by August 2005, which represents a construction schedule of more than 40 weeks. Hazen and Sawyer requests additional compensation for the additional office and

field time to complete Construction Quality Assurance (CQA) activities required for issuance of an Operations Permit by FDEP.

b. Bid Documents and Record Documentation Reports

Our original scope anticipated that the construction would be completed by a single contractor as a single construction project. To best meet its disposal needs, Lee County broke the construction project into two separate contracts that allowed the completion of Cell 5 for immediate disposal operations. Hazen and Sawyer prepared, at the County's request, separate Construction Drawings and Specifications for each of the contracts. In addition, we reviewed submittals from two contractors, often covering similar components. We had anticipated that review of only a single set of submittals would be required.

Upon completion of Cell 5, Hazen and Sawyer prepared a Record Documentation Report that documents the CQA testing, analyses and observation that supports the Construction Certification. Such a Certification, prepared, signed and sealed by Hazen and Sawyer's Engineer of Record, is required prior to FDEP issuance of the Operations Permit. Since the expansion area was divided into two projects, Hazen and Sawyer will issue a second Record Documentation Report upon completion of Cells 7-10. This second report is not in our scope of services.

4) Groundwater Mapping

The County is required to map groundwater flow characteristics on a semi-annual basis. Hazen and Sawyer is assisting the County by preparing the Groundwater Maps for submittal to the FDEP and adjacent property owners. Work associated with three sets of Groundwater Maps is considered out of our original scope of services and is related to the extension in the Phase 2 Expansion construction schedule.
