9. Background:

In accordance with Lee County Ordinance 04-18, the Enhanced 9-1-1 Telephone System Program Manager shall recommend approval for street name changes of existing plats within the unincorporated areas of Lee County. The reason for this action is an effort by the County to avoid any possible delays in service by police, fire and EMS responders as a result of the existing irregular house numbering system. The street name modification minimizes the effect on the residents by allowing the residents to maintain their current house numbers. All residents have been notified in advance of this change. No negative feedback has been reported from the residents. This design has been successful in other areas of the county and has been endorsed by the Lee County 9-1-1 Program.
