The Solid Waste Division is currently transferring 400 tons of MSW per day from the WTE facility to the Lee/Hendry landfill. The anticipated seasonal population increase as well as permanent population growth within Lee County indicates that a substantially higher MSW volume must be transferred on an ongoing basis therefore making the addition of one (1) Equipment Operator Senior necessary.

The four Operator Trainee positions are required to start-up and operate the newly built Reverse Osmosis Leachate Water Treatment plant at the Lee/Hendry landfill. The contractor is in the process of turning this facility over to the County.
