- 1. WHAT ACTION ACCOMPLISHES: Provides Lee County with a Contractor to act in an administrative role to oversee all aspects of the officials (Baseball and Softball) for the Gene Cusic Collegiate Classic. Contractor will hire, set umpire schedules, submit a weekly umpire schedule for each event coordinator, and have a designated softball supervisor available daily appointed by the Contractor with approval of the event coordinators, and ensure that all required paperwork is in order.
