Based on B&R's APC Enclosure (Pre-Engineered Metal Building) Bid Evaluation, dated 9/19/05 and posted on September 20, 2005, and the subsequent correspondence, Covanta concurs with B&R's selection and recommendation to purchase the subject package from Standard Industrial Structures Corp. (SISCORP) for the design and supply of this enclosure. Separate from this award, competitive bids for the erection of this material should be procured from SISCORP, the GC bidders and Alstom.

The following comments are for the County's consideration and guidance:

- Commercial Terms & Conditions No exceptions were taken to the T&C's provided in B&R's RFP assuming the attached sample insurance certificate is acceptable to the County. Additionally, SISCORP has offered \$500/day in liquidated damages for late delivery.
- Price: Covanta concurs with the Award Price of \$971,569 as confirmed in Vendor's 9/12/05 email to D. D'Amico and where \$334,985 is subject to escalation based on SISCORP's 9/13/05 email to D. D'Amico. This price includes minor adjustments based on a September 7, 2005 meeting and subsequent corespondence.
- Project Estimate: Project estimate assumed this enclosure would be supplied and erected by the GC. About 1/2 of the siding, lighting and HVAC estimate covers the APC enclosure and 321 tons of steel was estimated. Extracting these quantities from the GC estimate gives us \$1,831,044 to furnish and erect the APC enclosure (excluding roofing). Approximately 75% of this amount is estimated for the material portion or \$1,362,300 for comparison to this award price of \$971,569. This erection estimate for this scope is \$468,744 compared to SISCORP's tentative erection option price of \$332,122.
- Bond: Excluded. This is an equipment delivery only order, therefore County does not require a bond and is not included in the recommended award.
- Payment Terms: 10% upon drawings issued for construction; 90% upon delivery to site ~ all net 30 days. Plus 5% retention from each of the forgoing payments paid 60 days after complete delivery of materials.
- Schedule: A delivery date of October 15, 2006 is 2 weeks sooner than the Project Schedule requires. This is acceptable since it will allow the erector some early start flexibility.

B&R should proceed immediately with the following:

- 1) B&R to reconfirm the following items:
- a. Above total award price based on all of the detailed additions and deletions listed in B&R's "Proposal Technical Questions and Clarifications", and excludes bond cost.
 - b. Vendor shall PE stamp all building drawings.
- c. Enclosure scope has not changed due to any pending APC equipment relocations, or an added double door for access to the outdoor CEM enclosure.

- 2) Issue the County a purchase order term sheet that reflects the final agreements and understandings to be incorporated into the purchase order. This document shall include the detailed terms and formulas for calculating escalation;
- 3) Issue the conformed specification, with all scope items clearly included and excluded to reflect the final agreed to material supply only scope; eg: erection and roofing excluded;
- 4) Finalize SISCORP's separate/stand alone bid for the erection of their material supply (This activity is independent from issuing this PO).

There was no original schedule for issuing a PO for this particular scope. B&R's current schedule for issuing this PO was October 3, 2005. Covanta recommends that the County have this award approved by the BOCC no later than the October 18, 2005 BOCC Meeting.

LEE COUNTY WTE EXPANSION PROJECT FORT MYERS, FLORIDA RFP 2661-SA-506 APC Building Enclosure BID EVALUATION

The APC enclosure building is a specialty building with an irregular shape and requiring interface and interconnection with the existing buildings. Manufacturers of pre-engineered buildings typically supply stand alone off the shelf type regular buildings, such as warehouses, storage buildings, etc. However, the APC Building Enclosure has irregular shapes and contours, engineered design of structural steel, wall panels, HVAC units, controls, roofing, etc. Based on previous experience, SISCORP is the only large supplier capable of and interested in designing and furnishing this size specialty type building.

On June 15, 2005, Burns and Roe Enterprises, acting on behalf of Lee County, issued Request for Proposal No. (RFP) 2661-SA-506 "APC Enclosure" for the engineering, design, furnish and erecting this structure. The RFP was issued to Varco-Pruden, Butler Manufacturing, CECO Building Systems, and Standard Industrial Structures Corp. (SISCORP). As expected, only SISCORP submitted a proposal. On July 25, 2005 SISCORP's proposal was received and opened.

SISCORP's price to furnish and erect this building is \$1,411,457, broken down as follows:

\$967,367. Materials \$102,968. Roofing materials and installation \$332,122. Installation cost (Labor and Supervision) \$1,411,457.

SISCORP's proposal included clarifications/questions to the technical specifications. Burns and Roe reviewed these clarifications generated responses and submitted to SISCORP. An on-site meeting was conducted with SISCORP to review the proposal and questions. All questions and clarifications were resolved at that meeting. It should be noted that in the best interest of the Project, SISCORP scope of work is to supply only materials. Installation will by others. Roofing materials; however, will be furnished by the installation contractor in order to maintain roof warranty. Attached is the history of all communications with SISCORP.

RECOMMENDATION:

The recommended award of the contract is to Standard Industrial Structures Corp. (SISCORP). Recommended award price is \$971,569 FOB Jobsite, Freight Prepaid and Allowed and excludes cost of Bonds and Sales or Use Tax. This cost includes \$334,985 of materials, which is escalatable.

BID EVALUATION 2661-SA-506 "APC Building Enclosure" (cont'd...)

COMMERCIAL EVALUATION:

SISCORP's original proposal included installation that was subsequently removed from the scope of supply of the package. The material cost was \$967,367 plus escalation. After a site meeting with SISCORP and adjustments to the supply scope, SISCORPS material cost is \$971,569 (see 9/12/05 email). The escalatable portion (steel) is \$334,985 (see 9/13/05 SISCORP email). It identifies steel items, numbers of pounds, and the current price per pound. Escalation is based upon published price list of SISCORP's material supplier. SISCORP will increase or decrease the price of steel from quoted prices per pound to price per pound upon receipt of listed materials. SISCORP to provide actual invoice showing amount of change.

Payment terms are:

10% upon drawings submitted and approved

90% complete delivery of Materials to jobsite.

5% retention on all invoices, paid 60 days after material delivery completion

SISCORP has accepted Liquidated Damages for late material that delays installer, at a rate of \$500/day.

Approval drawings will be submitted 3-4 weeks after receipt of order.

Retention 5% withheld from each invoice and paid 60 days after complete delivery of Materials.

Liquidated Damages \$500.00/day for Materials not delivered to the jobsite which delays the progress of the erector.
