9. Background:

Letters of Qualifications were solicited on behalf of the Board of County Commissioners for Lobbying Services for RFQ-05-15 LEGISLATIVE AND AGENCY LOBBYING & OTHER SERVICES FOR LEE COUNTY.

The deadline for receipt of Letters of Qualifications was October 6, 2005. A total of three (3) Qualification Statements were received by the established deadline. All Qualification Statements were considered at the Selection Committee meeting held on October 14, 2005. The Selection Committee consisted of the following staff members: Pete Winton, Assistant County Manager as Chairman; Karen Hawes, Director of Human Services; John Yarbrough, Director Parks & Recreation, Rick Diaz, Director Utilities, Amy Davies, Dept of Transportation, and David Owen, Legal Advisor. All three (3) firms were selected for interview/presentations: The interview/ presentations were conducted on November 17, 2005. On the basis of the information submitted by the firms in their Qualification Submittals, and after conducting the interview/presentations with the "short-list" firms, the Committee agreed to recommend the following ranking of firms: (1) Nabors, Giblin & Nickerson; (2) J Keith Arnold & Associates and (3) Public Affairs Consultants.

The County will not be restricted to utilizing, on an exclusive basis, the services of Nabors, Giblin & Nickerson. The County may, at times need additional specialized lobbying services to enhance the position of the County on specific matters.

The negotiated Service Provider Agreement will be brought back to the Board for approval upon successful negotiations.
