- Whereas:** The state of Florida is committed to enhancing the quality of life and the safety of the millions of people who work, live, and vacation in the state; and
- Whereas:** Impaired driving is a serious crime, which contributed to 23,013 alcohol-related crashes in the state of Florida during 2004 resulting in 1,093 deaths and 17,580 injuries; and
- Whereas:** During the 2004 Christmas holiday, 33 people were killed in traffic crashes, 15 of which were alcohol related; and
- Whereas:** Statistics show that every 32 minutes someone in the United States dies in an alcohol or drug-related crash, and every two minutes someone is injured in an impaired driving crash; and
- Whereas:** Lee County supports and endorses the efforts of all law enforcement agencies participating in the Florida DUI Enforcement Crackdown from December 10, 2005 through January 1, 2006.

NOW, THEREFORE BE IT RESOLVED BY THE Board of County Commissioners of Lee County, Florida that we do hereby proclaim December 10, 2005 through January 1, 2006 to be:

YOU DRINK & DRIVE, YOU LOSE WEEKS IN FLORIDA

We support the initiatives of the mobilization, including public education and awareness and strong enforcement of Driving Under the Influence laws, and we encourage citizens of Lee County to drive responsibly and avoid the tragic consequences of impaired driving.
