



Installation shall be in accordance with Bentley Prince Street, Inc. instructions and the Carpet and Rug Institute (CRI) Standards for Installation of Textile Floorcovering Materials (104 for Commercial/105 for Residential).

Installation prices are based on carpet installation in an open, empty office/dormitory/quarters space on a "clean floor." A "clean floor" is one where the condition is appropriate to accept carpet with no additional preparation other than possibly sweeping clean. Installation shall be performed during normal hours of ordering agency, Monday through Friday, holidays excluded.

Installation prices do not include adhesive. Adhesives are available under SIN 31-603.

Additional services can be provided by Bentley Prince Street, Inc. through its Re:Source Americas Service Providers on an open market basis. Items such as carpet measurements, furniture lifting, furniture moving, floor preparation, take-up and disposal, after hours work, etc. are available through the Re:Source Project Management Department (800-336-0225 ext. 4483). Use of low VOC (volatile organic compound) emitting, low odor adhesives which help alleviate indoor air pollution will be used for all installations.

Subfloor preparation (take-up and disposal of existing floor covering, flashpatching for uneven floor, extensive cleaning, cost of temporary warehousing, etc.) is not covered by this contract. Bentley Prince Street, Inc. is prepared to negotiate these and other services with the customer agency on an open market basis. Payment for carpet purchased shall be made by the customer agency prior to installation. When installation is required in conjunction with carpet purchased under contract, the carpet may be invoiced separately.
