9. Background:

By indenture dated January 6, 1969, Betty Jean Evans and John L. Evans conveyed a <u>temporary</u> roadway turnaround easement to Lee County. The turnaround is located at the southeast corner of Staley Farms Road and Luckett Road. This instrument was recorded in the Public Records of Lee County, Florida, at Official Records (O.R.) Book 520, Page 797.

The easement was temporary and could be terminated or revoked upon six-months written notice to the County. Farasi Farm, LLC, is the successor in interest to Betty Jean Evans and John L. Evans, and has provided written notice to Lee County seeking to revoke or terminate the easement.

Book 520, Page 797 of the Public Records of Lee County, Florida, ("Easement");

WHEREAS, the Easement was temporary and contained a condition requiring the County, upon the receipt of six months written notice, to terminate its use and surrender as all right, title and interest in the Easement;

WHEREAS, Farasi is the successor in interest and title to Betty Jean Evens and John L.Evans, and by letter dated September 2, 2005, Farasi has requested Lee County to terminate its use and surrender as all right, title and interest in the Easement;

WHEREAS, it is the intent of the County to release to Farasi all right, title and interest in the Easement recorded in O.R. Book 520, Page 797 of the Public Records of Lee County, Florida.

NOW, THEREFORE, for and in consideration of the sum of One and xx/100 Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Lee County hereby conveys, sets over, remises and releases to Farasi Farms, LLC, their successors and assigns, all right, title and interest in Easement dated January 6, 1969, recorded in recorded in O.R. Book 520, Page 797 of the Public Records of Lee County, Florida.

This Release of Easement applies only to the interest of Lee County and its Board of County Commissioners in the Easement herein described, and does not warrant the title or represent any state of facts concerning the title.
