9. Background:

At the 9/20/05 meeting of the Board of County Commissioners, Blue Sheet No. 20051249 was approved. This action allowed for the donation of a 1996 Action Craft vessel, trailer and existing motor from the U.S. Fish and Wildlife Service to the Fort Myers Police Department, through Lee County. During the time the vessel was owned by Lee County, the County would affect minor repairs to the vessel caused by Hurricane Charley. These repairs were completed. During the course of these repairs, the existing engine was inspected. It was found that half of the cylinders had significant water intrusion. Therefore, Lee County purchased a new 115HP Evinrude (Serial No. 05121765, Model No. E115FPLSD) to be put on the vessel. The cost of the new engine under State Contract pricing was \$5,345.43. This engine does not fall under the purview of the previous action; therefore it needs to be donated to the Fort Myers Police Department.

All funds used to repair the vessel and acquire the motor are provided through the WCIND Navigational Improvements Projects (Projects 3079, 3094 and 3113) and are reimbursed by the West Coast Inland Navigation District.

1. ACTION REQUESTED/PURPOSE:

Accept donation of 1996 Action Craft vessel, motor and trailer from U.S. Fish and Wildlife Service (USFWS) to Lee County Div. Of Natural Resources. Execute Transfer of Property Form from USFWS. Declare all equipment surplus property. Donate same vessel, motor, and trailer from Lee County to Fort Myers Police Department.

Donation to Lee County allows the County to repair damage to vessel from Hurricane Charley prior to Fort Myers PD taking possession. Donations allow an unused patrol vessel to be put back into regular use by a Marine Law Enforcement agency.

9. Background:

In 1996, the U.S. Fish and Wildlife Service (USFWS) purchased a 1996 Action Craft vessel, motor and trailer through the West Coast Inland Navigation District's Waterway Development Program. (Project L-84) This vessel was used for the Service's marine law enforcement efforts. In recent years, the Service utilized the vessel sporadically and a newer vessel was purchased for similar use. The Service notified the County that they desired to remove the vessel from their inventory. The vessel incurred damage during Hurricane Charley in 2004 and the Service did not have the funds to effect repairs. The Fort Myers Police Department (FMPD) has expressed interest in taking possession of this vessel to patrol the Caloosahatchee River. Lee County will affect repairs to the vessel between the transfer from USFWS to FMPD. Funds for the repairs are available through WCIND.

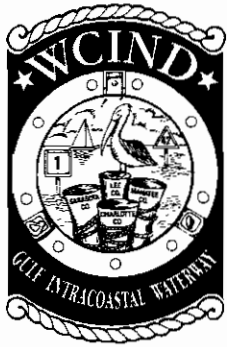

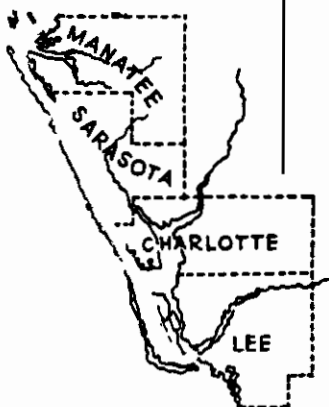
Dear Chris:


