The Board of County Commissioners adopted Lee County Ordinance No. 04-19, entitled, Lee County Cremation Fee Ordinance on October 26, 2004. The effective date of the Ordinance was November 1, 2004.

The District 21 Medical Examiner contacted Lee County to update <u>Section One</u>: <u>Setting of Fee</u> in Lee County Ordinance No. 04-19 to help defray the rising costs involved with cremation. If the amendment to the Ordinance is approved the effective date of the cremation authorization fee would be February 1, 2006. This date would allow the District 21 Medical Examiner to notify funeral homes of the increase.

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, AMENDING LEE COUNTY ORDINANCE NO. 04-19, RELATING TO CHARGING AND COLLECTING OF FEES BY THE DISTRICT 21 MEDICAL EXAMINER FOR PROVIDING EXAMINATIONS AND INVESTIGATIONS RELATING TO CREMATION, DISSECTION, AND BURIAL AT SEA; INCREASING THE FEES FROM TWENTY-FIVE DOLLARS (\$25.00) TO THIRTY DOLLARS (\$30.00); PROVIDING FOR THE ESTABLISHMENT OF A SCHEDULE OF FEES BY RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Lee County, Florida, previously adopted Ordinance No. 04-19, relating to the cremation fee; and,

WHEREAS, the effective date of Ordinance No. 04-19 was November 1, 2004; and WHEREAS, the Board of County Commissioners of Lee County, Florida, now desires to amend Lee County Ordinance No. 04-19 in order to increase the fee from Twenty-Five Dollars (\$25.00) to Thirty Dollars (\$30.00).

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA that:

SECTION ONE:

Medical Examiner's Office for Lee County.

District 21 Medical Examiner

A. Statement of Purpose

Cremation fee revision from Twenty-Five Dollars (\$25.00) to Thirty Dollars (\$30.00) regarding procedures for the charging and collecting of fees by the District 21 Medical Examiner for providing examinations and investigations relating to cremation, dissection, and burial at sea.

B. Narrative Summary of Ordinance (Several Sentence Summary)

Section 406.11(1)(c), Fla Stat., requires the District 21 Medical Examiner determine the cause of death for the District by such examinations, investigations, and autopsies as deemed necessary or as shall be requested by the State Attorney when a body is to be cremated, dissected, or burried at sea. These fees will be used to offset expenses of the Medical Examiner in Lee County.

 - 2. Do the anticipated fees cover the full cost of operation? If not, what percentage of the costs are covered? For FY05-06, \$84,000 in fee revenue is budgeted based on a \$25 fee, which represents approximately 4% of total budgeted expenses.
- E. Give a brief narrative analysis of the information contained in II, A-D, above.

Increasing the fee from \$25 to \$30 would generate an additional \$16,800 in fee revenue. The Medical Examiner receives 30% of fees collected; which means the Medical Examiner would earn an additional \$5,040 and the County would retain \$11,760.
