- 1. ACTION REQUESTED/PURPOSE: Authorize Chairwoman to sign a Memorandum of Understanding between Lee County and the Florida Department of Law Enforcement, which grants this State agency the authority to expend locally obligated funds from the 2005 Homeland Security Grant Program. No budget authority is required at this time.
- **2. WHAT ACTION ACCOMPLISHES:** Allows the Florida Department of Law Enforcement to disburse Homeland Security grant funding for eight regional domestic security task force planning positions, one of which will be coming to Lee County.
- 3. MANAGEMENT RECOMMENDATION: Staff recommends approval.

9. Background: The U.S. Department of Homeland Security granted \$525,000 to the State of Florida for eight planner positions as part of the 2005 State Homeland Security Grant Program funds. These positions would be responsible for planning, training, exercise, management and administrative duties supporting each regional domestic security task force throughout the State. One of these positions would be assigned to Lee County through the Lee County Emergency Management Program.

The Florida Department of Law Enforcement (FDLE) has asked Lee County to serve as the locally designated agency due to the requirement in the Homeland Security Grant Program guidelines that 80 percent of the funds must be obligated to a local unit of government. The attached Memorandum of Understanding allows Lee County to request that FDLE retain the funding for these positions on behalf of the local sponsoring governmental unit. This allows FDLE to enter into agreements with other agencies that would administer these positions, thus removing that burden and additional cost from the County. Lee County would receive a separate agreement for the position assigned to the Region 6 Domestic Security Task Force, at which time budget authority would be requested for just that portion of the allocated funding for that position.

MEMORANDUM OF UNDERSTANDING FOR EXPENDITURE OF LOCAL GOVERNMENT UNIT FUNDING FROM 2005 STATE HOMELAND SECURITY GRANT PROGRAM (SHSGP)

THIS AGREEMENT is entered into by and between the Lee County, Florida (Board of County Commissioners) (Local Government Unit) and the Florida Department of Law Enforcement (FDLE), hereinafter referred to as "the Parties".

WHEREAS, the U.S. Department of Homeland Security (DHS), Office of State and Local Government Coordination and Preparedness (SLGCP), Office for Domestic Preparedness (ODP), has made available the 2005 State Homeland Security Grant Program (SHSGP) funds to the Florida Department of Community Affairs (FDCA), as the State of Florida's State Administrative Agency under federal grant guidelines, which funds are designated to be used for planning, equipment, training, exercise, and management and administrative purchases and activities in Domestic Preparedness;

WHEREAS, pursuant to the authority of federal grant guidelines, the FDCA has awarded FDLE a portion of the 2005 State Homeland Security Grant Program (SHSGP);

WHEREAS, the 2005 Homeland Security Grant Program guidelines require the State of Florida (State) to obligate not less than 80% of the 2005 SHSGP funds to local units of government;

WHEREAS, the 2005 Homeland Security Grant Program guidelines require that, if the State retains a portion of said grant funds on behalf of a local government unit, the State must enter into a memorandum of understanding with the local unit of government, specifying the amount of funds to be retained by the State for expenditures; and

WHEREAS, the State and the Local Government Unit have utilized the State of Florida's State Homeland Security Strategies as the basis for the allocation of 2005 SHSGP funds to meet prioritized needs to enhance and refine their preparedness efforts, and have received state and federal approval for the allocation and expenditure of said funds as designated herein;

NOW, THEREFORE, the Parties agree to the following terms:

- The Local Government Unit requests the State, through FDCA and FDLE, to retain the amount of \$525,000.00 (Grant Fund Amount), as a portion of the Local Government Unit's allocation of the SHSGP portion of the 2005 Homeland Security Grant Program, for expenditures identified herein to be made by the State on behalf of the Local Government Unit.
- FDLE, representing the State in its administration of a portion of the 2005 SHSGP grant funds, agrees to retain and expend the Grant Fund Amount for identified expenditures, on behalf of the Local Government Unit.
- The expenditures to be made by the State through FDLE, on behalf of the Local Government Unit, consist of the planning, organizational, equipment, training, exercise, and/or management and administrative items identified below (Expenditures), under the authorized 2005 SHSGP activity/ activities designated below:

8 RDSTF Planner positions - 2005 Funding Issue #8b - \$525,000.00

FDLE will employ eight full-time, temporary planner positions and will make related, authorized expenditures for office equipment, supplies, travel costs, etc., to support the Local Government Unit, and regional response efforts, in conjunction with statewide domestic security efforts. One planner will be assigned to each of the seven Florida Regional Domestic Security Task Forces and one to the FDLE Office of Domestic Preparedness. Authorized regional planning related activities to be performed by the planners will be determined by the RDSTF and approved by the RDSTF Chair and Co-Chair.

This agreement terminates two years from the date of the award of the 2005 SHSGP funds to the State, or earlier a) as otherwise stated herein, b) as agreed to by the Parties, or c) as otherwise required by law or by state or federal guidelines.
