AMENDMENT TO THE CONTRACT BETWEEN LEE COUNTY BOARD OF COUNTY COMMISSIONERS AND SOUTHWEST FLORIDA PROFESSIONAL FIREFIGHTERS AND PARAMEDICS LOCAL 1826 INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, INC.

WHEREAS, Article 41, Section 41.1, of the current Collective Bargaining Agreement between the Lee County Board of County Commissioners (Lee County) and the Southwest Florida Association of Professional Firefighters and Paramedics, Local 1826, International Association of Firefighters, Inc. (Local 1826), provides that either Party to the Collective Bargaining Agreement may re-open up to two articles for the 2005-2006 contract year; and WHEREAS, Lee County and Local 1826 each opened two articles for the 2005-2006 contract year; and

WHEREAS, Lee County and Local 1826 met and negotiated a mutually satisfactory amendment to the Collective Bargaining Agreement covering the time period between October 1, 2003, and extending through September 30, 2006; and

WHEREAS, all other issues related to the Re-opener negotiations for the 2005-2006 contract year have been resolved.

NOW THEREFORE BE IT RESOLVED THAT the 2003 - 2006 Collective Bargaining

Agreement between Lee County and Local 1826, is hereby amended as follows:

SECTION ONE:

The amendment set forth in the following Article 20, Section 20.5 (B), is hereby adopted, with strike-through type being the language deleted and underlined text being language added:

ARTICLE 20, PAY PLAN Section 20.5 (B)

B. Effective upon ratification, each employee will receive the same CPI increase given to all non-exempt County employees for the 2003-2004, 2004-2005, and 2005-2006 contract years. In addition to the CPI increases listed above, all bargaining unit employees shall receive an additional three percent (3%) per year general wage increase for the 2003-2004, 2004-2005, and 2005-2006 contract years. These CPI and General wage increases will be effective October 1 of each of the second and third contract years. Nothing in this Section will result in any employee exceeding the maximum of the pay range under the Section above except that employees at the maximum of their classification's pay range as of October 1, 2005, shall receive the CPI increase. Employees at the maximum of their classifications' pay range shall not receive a General wage increase. Retroactive to October 1, 2003, all bargaining unit employees will receive a CPI and a three percent (3%) increase for the first year of the contract. (The 2003-2004 contract year).

SECTION TWO:

Except as herein amended, the 2003-2006 Collective Bargaining Agreement Between Lee County Board of County Commissioners and Southwest Florida Professional Firefighters and Paramedics Local 1826 International Association of Firefighters, Inc. shall remain in full force and effect.

SECTION THREE:

Pursuant to Section 447.309, Florida Statutes, the bargaining representative for Lee County and the bargaining representative for Local 1826 hereby confirm that the foregoing represents the Re-Opener Agreement for 2005-2006 which modifies the Collective Bargaining Agreement for 2003 - 2006, reached by the negotiators through collective bargaining.

SECTION FOUR:

This Agreement shall not be binding on Lee County, Florida, until it has been ratified by Lee County and by the employees who are members of the bargaining unit.
