- 1. ACTION REQUESTED/PURPOSE: Consider approval and authorize Chairwoman's signature on the "Fine Arts Loan Agreement between Lee County and Fort Myers' Williams Academy- Black History Society" for the loan and public display of a door-size Nigerian artwork at the Williams Academy Museum.
- 2. WHAT ACTION ACCOMPLISHES: Board of County Commissioner approval is required to finalize the agreement with the Black History Society. Approval and execution of the agreement will allow the Black History Society to display the artwork at the William Academy Museum for five (5) years.
- 3. MANAGEMENT RECOMMENDATION: Approval will allow the Black History Society the privilege of displaying this piece at the Museum.

## 9. Background:

On December 3, 1984, Bonita Springs resident, John West, presented a door-size ebony sculpture depicting an ancient Tribal King giving his blessing at a wedding ceremony- to Roland Estwood, Chairman of the Lee County Board of County Commissioners "for the people of Lee County to promote international goodwill among local residents." The sculpture was created in 1974 by Nigerian Artist G. Ehighator, and consists of carved ebony triptych door panels with an appraised value of \$25,000.00.

The Black History Society ("Society") operates the Williams Academy as a black history museum with the purpose of the museum being to gather and preserve the history of African Americans in Lee County and to record past achievements. The Society has requested that the Board of County Commissioners grant it the privilege of displaying the Nigerian piece of artwork at the Museum for the next five years.



## FINE ARTS LOAN AGREEMENT BETWEEN LEE COUNTY AND FORT MYERS' WILLIAMS ACADEMY - BLACK HISTORY SOCIETY

This Agreement entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2006 between LEE COUNTY, a political subdivision of the State of Florida, by and through its Board of County Commissioners hereinafter called "Lender" and the FORT MYERS' WILLIAMS ACADEMY-BLACK HISTORY SOCIETY, a not-for-profit entity, hereinafter called "Society" and collectively called the "Parties".

WHEREAS, the Society occupies a historic building known as the Williams Academy;

WHEREAS, the Society operates the Williams Academy as a black history museum with the purpose of the museum being to gather and preserve the history of African Americans in Lee County and to record past achievements;

**WHEREAS**, the Museum houses exhibits on many subjects ranging from religion to business and contains photos, trophies and artifacts;

WHEREAS, Lender owns a door-size Nigerian artwork, carved from ebony, that depicts tribal King Oba giving his blessing at a wedding ceremony. This lovely wood carved piece was donated from the president of the Federated Republic of Nigeria to Bonita Springs resident John West, who donated it to the Lee County Commission in 1984; and

WHEREAS, the Society has requested that the Lender grant it the privilege of displaying this piece at the Museum;

**NOW THEREFORE**, the Parties agree that the artwork will be displayed at the Museum, subject to the following terms and conditions:

I. Purpose of Loan: To Preserve Art and History

II. Owner of Artwork: Lee County Board of County

Commissioners

III. Title of Work & Value: "Door Artwork" Tribal King - three (3)

carved ebony Triptych Door Panels by G. Ehigiator - Appraised Value \$25,000.00

IV. Display Dates: The described item(s) are on loan for a

period of five (5) years beginning on the date this agreement is signed by both

Parties.

## LOAN CONDITIONS

- 1. Under the terms of this Agreement, the Fort Myers' Williams Academy, Black History Society (the "Society") will exercise the same care in respect to all lent artwork or artifacts, as it does in the safekeeping of its own property.
- 2. Objects lent to the Society for exhibition or extended loan shall remain in its possession for the time specified in the Loan Agreement. Loans will be returned only to the Owner or Lender, or to his or her authorized agent or representative.
- Objects lent to the Society will be insured by the Society at the written valuation provided by the Lender. However, the Society and/or its insurer reserve the right to substantiate the value of any artwork that is damaged prior to settling a claim with the owner of the art. All objects lent will be insured under the Society's fine arts allrisk, wall-to-wall coverage.
- 4. If the Lender elects to insure the objects on loan to the Society with its fine arts insurance, the Society accepts no responsibility for damaged artwork, except in cases involving negligence by the Society and its employees and agents.
- 5. If legal ownership of the item(s) shall change during the period of the loan, whether by reason of sale, gift or otherwise, the new owner may, prior to its return, be required to establish his or her legal right to receive the item(s) by proof satisfactory to the Society.
- 6. Attributions, dates and other information shown on the face of this Loan Agreement are as given by the Lender. Any valuations shown are those stated by the Lender and are not to be considered as appraisals by the Society.
- 7. The Society accepts this loan with the understanding that the Lender has full authority to make the same.
