8. **Background:**  
The Bureau of Justice Assistance is offering funding for bulletproof vests for law enforcement officers. Under the guise of their definition of law enforcement officer, certified law enforcement deputies and certified correction officers may receive a vest from these funds. The Lee County Sheriff's Office is requesting reimbursement for the purchase of 92 vests, 32 for SOU members and 60 for certified deputies and correction officers.

The total cost of the vests is \$57,422.00. The 50% match of \$28,711.00 will come from the Lee County Sheriff's budget. P.M.


