1. ACTION REQUESTED/PURPOSE: Award B-06-11 STRINGFELLOW ROAD SIDEWALKS to the lowest responsive, responsible bidder, Gulf Paving, Inc., in the not-to-exceed base bid amount of \$1,509,317.00, plus the alternate amount for Arthur Avenue of \$170,502.50. Also, authorize Chairwoman to execute contract on behalf of the Board upon receipt. This project was anticipated and funds are available.

2. WHAT ACTION ACCOMPLISHES: Provides Lee County with a Contractor to construct sidewalks and associated drainage improvements on Stringfellow Road. The alternate provides sidewalk construction/drainage improvements on Arthur Avenue.
