Temporary Loan is requested by Good Wheels to address a cash flow shortage until reimbursement is received from Florida Department of Transportation (FDOT), for services relating to the disabled and disadvantaged. Authorize transfer of General Fund Reserves to provide the loan funds to Good Wheels.
- 2. WHAT ACTION ACCOMPLISHES: Ensures no interruption of transportation services to the disabled and disadvantaged passengers.

Good Wheels financial condition regarding their payroll obligations was discussed at the April 11, 2006, Board of County Commissioners Meeting (BOCC) as a Commissioners' Item. Staff was directed to bring the item back to the next meeting of the BOCC.

Good Wheels is the Community Transportation Coordinator for Lee County providing certain transportation services to the disabled and disadvantaged clients. Good Wheels is paid by FDOT for a variety of federal and state funded programs. As a result of payment delays, Good Wheels has requested a temporary "bridge" loan to satisfy their current payroll obligations. Without this loan, such transportation services could be jeopardized. The expenses relating to this loan are to be properly documented. Payback to the County is due fourteen (14) days after Good Wheels' receipt of payment from FDOT. The temporary loan can not be extended beyond thirty (30) days from execution of this Agreement without Board approval.

To Whom It May Concern:

Thanks again for all your support.

Each month we receive 4 Lee County payments from the State of Florida. Those payments are for:

- a. First and second half of the month Medicaid (Medicaid contract), and
- First and second half of the month Transportation Disadvantaged Non-sponsored transportation (TD Grant).

There is a very bureaucratic process that the State follows that has to occur to get those funds, but the real problem lies in the irregular schedule on which those payments are made. We can receive payments anywhere from 10 - 60 days from the time of completion of any billing period. We have repeatedly asked the TD Commission to set up a regularly scheduled automatic payment by electronic transfer, but our efforts have not proven to be successful.

We must pay employees bi-weekly, without fail, as well as weekly and monthly automatic fuel, parts, and insurance payments from our cash account. Since we never know for sure when our State payments are going to hit our account, we can sometimes get in a bind for payroll cash, until those State payments do arrive. We are operating within our allotted funding and budget, we just never know when the cash payments will arrive.

Our immediate need is for a "bridge loan" in the amount of \$100,000 to cover payroll for the week of April 21, 2006. Our payroll funds must be wire transferred to our payroll agency not later than Wednesday, April 19, 2006. We suspect that our State payments will arrive by then, but we are not sure that will occur. Since we are not sure at this time when the February and first half March payments will arrive, we suspect it better to start the loan approval and administrative process sooner rather than later.

We agree that if funds are not needed we won't take any loan money, and we also agree that we won't take a loan for anymore than the total amount rightfully owed us by the State of Florida for work already completed and properly invoiced. We also agree to payback any "bridge loan" funds in full within 14 days of receipt of our total monthly payments from the State of Florida.

Another question would be, is the Lee County BOCC approval of this request a one time one week request or could this be an open request for anytime in the near future that this funding delay might occur? We foresee that this payment scheduling problem will be reoccurring and not resolved in the near future. An ongoing provision for a loan would be greatly appreciated and probably needed.

We will be glad to assist you in anyway that we can, and do sincerely apologize for any unnecessary work caused to the county staff.
