Background: Florida Communities Trust (FCT) is a State funded grant program that has awarded \$11,688,669.70 to Lee County for a percentage of the acquisition costs for four Conservation 20/20 sites # 59 (San Carlos Bay – Bunche Beach Preserve), #108 (Caloosahatchee Creeks Preserve), #194 (Prairie Pines Preserve), and #200 (Wild Turkey Strand Preserve). One of the requirements to receive this funding is to change the zoning district and Future Land Use Map to conservation, open space, parks or other comparable designations. The Future Land Use Map has been changed for the four FCT projects, but the zoning designations have not yet been changed.
