WHEREAS, the Board has carefully reviewed the bequest and finds that the acceptance of the donation from Ms. Betsy Ed Dornseif serves a valuable public purpose and is in the public's interest.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS that:

- 1. The above recitations are true and accurate and are hereby adopted and incorporated herein as if set out at length.
- Lee County recognizes and accepts the donation and transfer of the funds to Lee County.

- 3. Lee County agrees to use the funds for books for the Fort Myers Library.
- 4. In order that the proposed transaction is more efficiently consummated, the Board specifically authorizes and directs the Chairwoman or Vice Chairman of the Board of County Commissioners to execute any and all necessary documents for the said transaction on behalf of the Board of County Commissioners.
- 5. This Resolution shall become effective immediately upon its adoption.
