9. Background:

An executed contract was distributed to Wright Construction Company (WCC) on April 30, 2004 with a final completion date of April 9, 2005. The contract calls for the installation of an Ultra Filtration and Reverse Osmosis System for treatment of landfill by-product (leachate). During the current 13 month completion delay, the contractor has failed to provide sufficient labor and materials to complete the project. WCC has persistently failed to maintain the contract schedule and ultimately has failed to achieve final completion. The facility has not been completed nor has it performed as required under the Contract Documents.

The Solid Waste Division estimates that WCC has incurred over \$60,000 in liquidated damages to date.

Lee County (County) hereby issues this letter as a Notice of Termination in accordance with Article 12.03(2) (pg 37) of the Construction Manager Agreement between the Board of County Commissioners, Lee County, Florida and Wright Construction (WCC). WCC has persistently failed to maintain the contract schedule and ultimately has failed to achieve final completion prior to April 9, 2005. Since previous notice, WCC has made no significant effort towards achieving project completion prior to the notice date as most items under the previous correspondence, dated April 24, 2006, have yet to be completed.

Article 12.03(2) states that the Contractor, WCC, is allowed a 14 day notice to cure these violations. If the project is not completed prior to June 8th, the contract will be terminated and the County will assume control of the project facility as well as all rights appropriated to the County under the conditions of termination in accordance with Article 12 and the other related provisions of the contract which may include, but is not limited to, the pursuit of damages incurred due to the delay as well as costs required to complete the project.
