As we have discussed over the past couple of weeks, the increases in fuel prices, insurance costs (even w/no claims) and other business costs have reached a point where it is not profitable for Arbor One to continue mowing our designated parks under the current contract.

We have discussed the possibility of various options with Lee County Purchasing however feedback indicates a lack of ability to change our current contract to include market cost increases beyond the CPI. I understand this type of clause is included in other Lee County contracts.

As a result, per the agreement we are providing notice that Arbor One is resigning from the parks mowing current contract in 30 days from the date of this letter.

Based on our past performance, and the fact that our resignation is for economic reasons that could not have been foreseen at the time of the contract origination, I respectfully request the ability to participate in quoting for the next parks mowing contract.
