Background: The Lower West Coast Water Supply Plan has been under development for two years, but legislative changes in 2005 required a reworking of the drafts underway, and established new deadlines. The draft under review was released for review on June 12th. It will have a public workshop on June 26th, and staff will present any concerns to the Board on June 27th. The SFWMD will be receiving the Plan and is scheduled to accept the Plan, with any amendments, on July 12th.

The Plan sets forth the basic criteria by which water supply plans by local governments and other water supply entities will be judged for acceptance and for eligibility for fiscal assistance from SFWMD. The Plan should next be updated in 5 years.
