Subject: Sole Source Waiver

Would you please prepare a bid waiver to use Eurocopter as a sole source for helicopter airframe parts and repair of airframe parts.

The bid waiver is necessary because Eurocopter is the sole distributor of helicopter parts for aircraft operating in North America. Helicopter parts are costly and will generally exceed single vendor spending limits in a fiscal year.

This action allows Public Safety – EMS to have an open-ended bid waiver that will stay in effect as long as we are operating AEC helicopters. The bid waiver amount should be approximately \$300,000.00 annually.
