The Lee County Sheriff's Office (LCSO) has remaining SCAAP funds received for the reimbursement of housing illegal criminal aliens in Lee County Detention facilities. Funds remaining are as follows:

- 2003: \$ 703.24
- 2004: \$25,077.10
- 2005: \$ 5,635.00

**Total remaining: \$31,415.34**

The LCSO requests the reallocation of funds accordingly:

- \$7,500.00: Funds to be used for Florida FBI National Academy Associates, Inc. training session
- \$21,104.28: Funds to be used for the purchase of law enforcement traffic control vests and strobes
- \$2,811.06: Funds to be used to purchase equipment for Project Life Saver and training associated with the equipment.

No additional match is required.
