9. Background:

Prior to the construction of the recreation center at Estero Community Park, a request was submitted to construct a larger gymnasium than was originally anticipated. The extra space would accommodate one additional volleyball court. Instead of having two volleyball courts, Estero Community Park will have three courts.

The USA South Athletic Foundation pledged \$200,000 to cover the additional costs for the larger center. The additional court is needed due to the increased interest in the sport. The volleyball courts will be used by local traveling teams, girls' high school teams and additional practice sessions and tournaments.
