Lee County purchased a 30' Playcraft pontoon workboat in 1993 using grant funds from WCIND to be used on County waterways to perform maintenance on inshore and offshore County assets, such as channel markers, regulatory signs and buoys, and removal of derelict vessels. This vessel has performed thousands of hours of valuable service for the County in its 13 years of service. It was also available for post-disaster inspections and debris removal. With the recent purchase of a new workboat, Lee County has no more need to maintain the older pontoon boat. However, the WCIND Director has expressed interest in utilizing this vessel for lighter duty work in other areas of the District, which include Charlotte, Sarasota, and Manatee Counties.
