ACTION REQUESTED/PURPOSE: Award B-06-36 LAKES PARK WATER FEATURE, to the low bidder meeting all bidding requirements, Aquamarine Swimming Pool Company, for a lump sum amount of \$389,000.00, with a final project completion time of 120 days. Also, authorize Chairwomen to execute agreement on behalf of the Board upon receipt. This project is in the Operating Budget and funds are available.

2. WHAT ACTION ACCOMPLISHES: Provides Lee County with a contractor to furnish all labor, engineering, materials and equipment for the complete installation of a 4,000' water feature to be located at Lakes Park 7330 Gladiolus Drive Fort Myers FL .
