Some veterinarians stated that if the County only maintained a single fee for licensing that was good for the duration of the rabies vaccine (i.e. 3 year tags for three-year valid vaccinations) then veterinarians may be forced to make vaccination decisions on the basis of the fees rather than their medical choice. Apparently annual vaccination in cats is still considered among the best course of vaccination according to some area veterinarians. Other veterinarians choose to only use an annual rabies vaccination, rather than one with a longer duration, as a method of assuring that clients get an annual check up for their pets.
