**1. ACTION REQUESTED/PURPOSE:** Award B-06-31 SIGNALIZATION FOR DEL PRADO BOULEVARD AND CORONADO PARKWAY to the lowest responsive, responsible bidder, Southwest Signals, Inc., in the not-to-exceed amount of \$196,863.26 with a project completion time of 180 calendar days. Also, authorize Chairwoman to execute agreement on behalf of the Board upon receipt. This project was anticipated and funds are available.
