9. Background:

The Department of Transportation submitted a request to Contracts Management to bid the Corkscrew Road Widening From Ben Hill to East of Bella Terra project. The anticipated cost required the use of the formal, advertised seal bid procedure.

On the bidding deadline of December 12, 2006, Contracts received seven (7) bids. The bids have been reviewed by the Department of Transportation and the projects' consultant, Hole Montes and it is being recommended that award be made to the lowest responsive/responsible bidder, Mitchell & Stark Construction Co., Inc., in the not-to-exceed amount of \$14,966,373.91.


