## Lee County, Florida Position Statement on the Proposed Transit Authority

The Lee County Board of County Commissioners endorses submittal of the formation of a transit authority to the electorate under the following conditions:

- Support by all jurisdictions of Lee County, who through adoption of a binding resolution, have demonstrated their support for the formation of a transit authority that provides a funding mechanism for the operation of a multi-modal transit system; and
- Provides for a governance structure that allows for equitable representation of all jurisdictions of Lee County which recognizes population, taxable value and the number of registered voters; and
- Incorporates the adoption of position statements of all participating jurisdictions; and
- Adheres to adopted state and local comprehensive plans, Lee County's Smart Growth plan and transportation plans including the Ten -Year Transit Development Plan and the MPO's Long Range Transportation Plan; and
- Has established goals and objectives which promote an efficient and accountable operating structure, promote eco-sensitive policies, strives to make public transit and other mobility options accessible and available to the residents of Lee County; and
- Recognizes the input of each participating jurisdiction and Lee County government as representative for unincorporated areas of Lee County, in decisions related to transit services, routes, facilities, transit stops, or vehicle types operating within or impacting the jurisdiction.
