behalf of the Office of E	qual Opportunity ("LCOEO.")

WHEREAS, FGCU and the BCC entered into a Memorandum of Understanding dated March 14, 2006 ("MOU"), whereby FGCU-SBDC would perform certain services with respect to the administration of LCOEO's Disadvantaged Business Enterprise Program; and

WHEREAS, FGCU and the BCC desire to extend the time period for performance of the services contemplated under the MOU.

NOW, THEREFORE in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. TERM OF AGREEMENT

The term of the Agreement is hereby amended to cover the time period from January 1, 2007 through December 31, 2007.

2. <u>COMPENSATION</u>

Payment of compensation to FGCU is hereby amended as follows:

LCOEO agrees to pay FGCU \$65,000 (sixty-five thousand dollars) for the execution and completion of services for the 2007 calendar year. Payments will be made in two equal lump sums of \$32,500.00. The first payment is payable upon execution of this Amendment and the second will be made in June 2007.

In all other respects, and except as specifically modified and amended herein, the Agreement dated March 14, 2006, shall continue in full force and effect as written and the parties hereto agree to be bound thereby.
