Background: The County having acquired, through the Conservation 20/20 program in late 2005, the Daniels Preserve at Spanish Creek located in Alva. The project consists of approximately 12 acres of a 243 acre Conservation 20/20 preserve. The Brazilian pepper adjacent to the borrow pits and eastern fence line will be removed mechanically with heavy equipment. The pepper will be chipped and left on upland portions of the site.

### PURCHASE ORDER TERMS AND CONDITIONS

This PURCHASE ORDER constitutes a binding contract between the South Florida Water Management District (DISTRICT) and the VENDOR as named on the PURCHASE ORDER when accepted by the VENDOR either by express acknowledgment or by commencement of shipment without reservations.

INVOICES AND PAYMENTS. The VENDOR shall submit a separate invoice for each purchase order or purchase release after each delivery. Invoices for other than lump sum payments shall be substantiated by adequate supporting documentation, including an itemization of the date, hours expended, description of the deliverable, and, if applicable, transportation charges, the bill of lading and the freight waybill. The VENDOR's invoices shall reference the DISTRICT'S PURCHASE ORDER number and shall be unaited to ACCUINTS PAYABLE. South Florida Water Management District, Box 24682, West Palm Beach, FL 33416-4680. It is the policy of the DISTRICT that payment for all goods and survices shall be made in a timely manner and that interest payments are made on late payments. In accordance with Florids Statutes, Section 218.70, Florida Prompt Payment Act, a "proper" invoice is defined as an invoice that conforms to all statutory requirements and all DISTRICT requirements as specified in the PURCHASE ORDER for invoice submission. The time at which payment shall be due from the DISTRICT shall be forty-five (45) days from receipt of a proper invoice and acceptance of deliverables, based on compliance with the statutory requirements set forth in Section 218.70, Fl.s. and upon satisfaction of the DISTRICT conditions that are detailed herein. If all conditions are met and payment is not made by the DISTRICT in this timeliance, interest shall accove after 30 days at the rate of 1½ per month on the unpaid balance. The VENDOR must invoice the DISTRICT for any accrued unpaid interest.

INDEMNIFICATION. For value received, the VENDOR shall indomnify and hold the DISTRICT, its officers, directors, board members, agents, assigns, and employees harmless from liabilities, damages, losses and costs, including, but not limited to reasonable attorneys fees, to the extent caused by the negligence, recklessness or intentionally wrongful conduct of the VENDOR and other persons employed or utilized by the VENDOR in the performance of the PURCHASE ORDER. The VENDOR further acknowledges that it is solely responsible for oraquing its compliance and the compliance of its subcontractors, suppliers, agents, assigns, invites and employees with the terms of this PURCHASE ORDER. This paragraph shall survive the expiration or termination of this PURCHASE ORDER.

TERMINATION FOR DEFAULT. In accordance with DISTRICT Rule 40E-7, Part II, F.A.C., "material breach" is defined as any substantial, unexcused non-performance by failing to perform an act that is an important part of the transaction or performing an act inconsistent with the terms and conditions of the PURCHASE ORDER. If the VENDOR materially fails to failful is obligations under this PURCHASE ORDER, the DISTRICT will provide written notice of the deficiency by forwarding a Cure Notice citing the specific nature of the material breach. The VENDOR shall have thirty (30) days to cure the breach. If the VENDOR fails to cure the breach within the thirty (30) day period, the DISTRICT shall issue a Termination for Default Notice. Once the DISTRICT has natified the VENDOR that it has materially breached its PURCHASE ORDER with the DISTRICT, the DISTRICT's Groverning Board shall determine whether the VENDOR should be suspended from doing future work with the DISTRICT, and if so, for what period of time. Should the DISTRICT terminate for default in accordance with this provision, the DISTRICT shall be entitled to recover representment costs in addition to all other remedies under law and/or entitle.

TERMINATION FOR CONVENIENCE. The DISTRICT may terminate this PO with or without cause at any time for convenience upon 30 calendar days prior written notice to the VENDOR. In the event of termination for convenience, the DISTRICT shall compensate the VENDOR for all authorized and accepted deliverables and/or services completed through the date of termination in accordance with the Statement of Work. The DISTRICT shall be relieved of any and all future obligations hereunder, including but not limited to lost profits and consequential damages, under this PURCHASE ORDER. The DISTRICT may withhold all payments to the VENDOR for such work undis auch time as the DISTRICT determines the exact amount due to the VENDOR. In the event a dispute arises which the project managers cannot resolve between themselves, the parties shall have the option to submit to nonbinding mediation.

RECORDS RETENTION/AUDIT. The VENDOR shall maintain all records, books and documents pertinent to the performance of this PURCHASE ORDER in accordance with generally accepted accounting principles consistently applied. The DISTRICT shall have inspection and audit rights to such records for a period of 5 years from final payment under this PURCHASE ORDER. Records relating to any logal disputes arising from performance under this PURCHASE ORDER shall be made available until final disposition

NONDISCRIMINATION. The VENDOR hereby assures that no person shall be excluded on the grounds of race, color, creed, national origin, handicap, age or sex, from participation in, denied the benefits of, or otherwise he subjected to discrimination in any activity hereunder. The VENDOR shall take all measures necessary to effectuate these assurances.

PUBLIC ENTITY CRIMES/SDN LIST. The VENDOR, by its execution of this PURCHASE ORDER or by commencement of shipment with reservations, acknowledges and arrests that neither it, nor any of its suppliers, subcontractors or consultants who shall perform work which is intended to benefit the DISTRICT is included on the U.S. Department of Treasury's List of Specially Designated Nationals and Blocked Persons, is a State of Florida convicted wender or is included on State of Florida's discriminatory vendor first, and if the VENDOR or any affiliate of the VENDOR has been convicted of a public entity crime or has been placed on the discriminatory vendor first, a period longer (than 36 months has passed since placement on one of either of these lists. The VENDOR further understands and accepts that this PURCHASE ORDER shall be either void or subject to introduste termination by the DISTRICT, in the event there is any misrepresentation or lack of compliance with the laws and regulations of the U.S. Department of Treasury and/or the mandates of Section 287,133 or Section 287,134, respectively, Florida Statutes. The DISTRICT, in the event of such termination, shall not incur any liability to the VENDOR for any work or materials furnished.

<u>PUBLIC ACCESS</u>. The VENDOR shall allow public access to all project documents and materials in accordance with the provisions of Chapter 119. Florida Statutes. Should the VENDOR assers any exemptions to the requirements of Chapter 119 and related Statutes, the burden of establishing such exemption, by way of injunctive or other relief as provided by law, shall be upon the VENDOR.

DISTRICT'S TAX EXEMPTION. The VENDOR shall not utilize the DISTRICT's exemption certificate number issued pursuant to Sales and Use Tax Law, Chapter 212, Florida Statutes, when purchasing materials used to fulfill its contractual obligations with the DISTRICT. The VENDOR shall be responsible and liable for the payment of all applicable FICA/Social Security and other taxes resulting from this PURCHASE ORDER.

ASSIGNMENT/GUARANTOR. The VENDOR shall not assign, delegate or otherwise transfer its rights and obligations as set forth in this PLIRCHASE ORDER without the prior written consent of the DISTRICT. Any attempted assignment in violation of this provision shall be null and void. The VENDOR shall not pledge the DISTRICT's credit or make the DISTRICT's quarantor of payment or surety for any contract, debt, obligation, judgment, fion, or any forth of indebtedness.

FORCE MAJEURE. Notwithstanding any provisions of this PURCHASE ORDER to the contrary, the parties shall not be held liable for any failure or delay in the performance of this PURCHASE ORDER that arises from fires, floods, strikes, embargoes, note of the public enemy, unusually severe weather, outbreak of war, restraint of Government, note, civil commotion, force majoure, act of God, or for any other cause of the same character which is unavoidable through the exercise of due care and beyond the control of the parties. Failure to perform shall be excused during the continuance of such circumstances, but this PURCHASE ORDER shall otherwise remain in effect.

AMENDMENTS. This Purchase Order may be amended or rescinded only with the written approval of the parties hereto.

ORDER OF PRECEDENCE. Any inconsistency in this PURCHASE ORDER shall be resolved by giving precedence in the following order: (1) PURCHASE ORDER terms and conditions; (2) Specifications; (3) all other documents, including, but not limited to, drawings, descriptions, sample(s).

ENTIRE AGREEMENT. This PURCHASE ORDER states the entire understanding and agreement between the parties and no course or prior dealing, usage of the trade or extrinse or parol evidence shall be relevant to supplement, vary or explain any term used with respect to this PURCHASE ORDER. VENDOR TO PACKAGE GOODS. VENDOR will package goods in accordance with good commercial practice. The VENDOR warrants that the goods furnished will confurn to the specifications, drawings and descriptions listed in the offering document or to the sample(s) furnished.

TERMS/PROVISIONS. Should any term or provision of this PURCHASE ORDER be held, to any extent, invalid or unenforceable, as against any person, entity or circumstance during the term hereof, by force of any statute, law, or ruling of any forum of competent jurisdiction, such invalidity shall not affect any other term or provision of this PURCHASE ORDER, that the PURCHASE ORDER shall remain operable, enforceable and in full force and effect to the extent permitted by law.

### Additional Terms and Conditions for Services:

STATEMENT OF SERVICES. The CONTRACTOR shall, to the satisfaction of the DISTRICT, fully and timely perform all work items described in the "Statement of Work", attached to this PO and incorporated herein. As part of the services to be provided by the CONTRACTOR under this PO, the CONTRACTOR shall substantiate, in whatever forum reasonably requested by the DISTRICT, the methodology, lab analyses, scientific theories, data, reference materials and research notes to formulate its opinions and testimony. This paragraph shall survive the expiration or termination of this PO. The parties agree that time its of the susence in the performance of each and every obligation hereunder. In the event CONTRACTOR

employees or hired workers are authorized by the Statement of Work to perform survices on-site at DISTRICT facilities, the CONTRACTOR hereby agrees to be bound by the DISTRICT policies and standards of conduct listed in the atrached "Contractor Policy Code Acknowledgement" and shall require each individual performing such on-site work to execute the from

COMPENSATION/CONSIDERATION. The total consideration for all work required by the DISTRICT pursuant to the PO shall not exceed the amount includes all expenses the CONTRACTOR may incur and therefore no additional compensation shall be authorized. The CONTRACTOR, by executing the PO or by commencement of work without reservations, certifies to truth-in-negotiation, specifically, that wage rates and other factual unit costs supporting the consideration are accurate, complete and current at the time of contracting. If the total consideration for this PO is subject to multi-year funding allocations, funding for each applicable fiscal year of this PO will be subject to DISTRICT Governing Board budgetary appropriation. In the event the DISTRICT does not approve funding for any subsequent fiscal year, this PO shall tenyingate upon expenditure of the current funding, notwithstanding other provisions in this PO to the contrary. The DISTRICT will notify the CONTRACTOR in writing after the adoption of the final DISTRICT hudget for each subsequent fiscal year if funding is not approved for this PO.

INSURANCE. The CONTRACTOR shall produce and maintain, through the term of this PO, insurance coverage reflecting, at a minimum, general liability and automobile liability each with a limit of not less than \$300,000.00, and all Plorida statutory workers' compensation insurance. The coverage required shall extend to all employees and subcontractors of the CONTRACTOR. The attached Certificate of Insurance shall be completed in full, indicating the producer, insured, carrier's name, and BEST rating, policy numbers and effective and expiration dates of each typu of coverage required. The Certificate of Insurance shall be signed by an authorized representative and shall identify the DISTRICT as added insured as required.

OWNERSHIP. The DISTRICT shall retain exclusive title, copyright and other proprietary rights in all work items, including, but not limited to, all documents, teclurical reports, research actes, scientific data, computer programs, including lite source and object code, which are developed, created or otherwise originated herounder by the CONTRACTOR under this PO. Any equipment purchased by the CONTRACTOR with DISTRICT funding shall be returned and title transferred from the CONTRACTOR to the DISTRICT upon expiration or termination of the PO.

COMPLIANCEALCENSES. The CONTRACTOR, its employees, subcontractors or assigns, shall obtain, at its own expense, all licenses, permits and other authorizations necessary to comply with all applicable federal, state and locus laws and regulations relating to the performance of the PO. The CONTRACTOR shall be responsible for verifying employee authorization to work in the U.S. and certifying that a good faith effort has been made to properly identify employees by timely reviewing and completing appropriate documentation, including but not limited to, USCIS Form I-9. Written verification shall be kept by the CONTRACTOR and made available for inspection on domaind by the District. The hourly rate of pay for each employee shall camply with State law and industry standards for similar work performed under the CONTRACT. The CONTRACTOR shall maintain records verifying the rate of pay for each employee working on this CONTRACT and make such records available for inspection on demand by the District. Failure to comply with these provisions shall be a material breach of the CONTRACT and cause for termination of the CONTRACTOR

CHANGE IN PERSONNEL. The District may at any time and at its sole discretion request that the CONTRACTOR replace any CONTRACTOR personnel provided by the CONTRACTOR to work on this CONTRACT if the District believes that it is in the best interest of the District to go. The District may, but will not be required to provide a reason for requesting the replacement of personnel. Such change in personnel shall be made immediately upon the District's written request for a change of personnel. The CONTRACTOR will place the above language in any CONTRACT that it has with subcontractors. The CONTRACTOR will enforce the replacement of subcontractorpersonnel upon a request by the District.

# Brazilian Pepper Removal Daniels Preserve @ Spanish Creek

### 1. Introduction

Lee County purchased Daniels Preserve at Spanish Creek, located in Alva, in late 2005 through its conservation lands program. The project area encompasses portions of the 243 acre Preserve. The District and County are working on the Four Corners Plan to provide water quality treatment and flood control for the area. Exotic removal, recontouring portions around the borrow pits, and rehydation of Spanish Creek will be considered. Removal of the Brazilian pepper monocultures will allow District and County staff to make better informed decisions for this restoration project.

The project area consists of approximately 12 acres of a 243 acre Conservation 20/20 preserve that includes hydric hammocks, cypress domes, mesic hammock, mesic flatwoods, hydric hammock, disturbed areas and the historic Spanish Creek Riverbed. Work, at this point, will be limited to exotic plant removal, primarily Brazilian pepper, along the eastern fence line and along the borrow pits and adjacent cypress head. Removal of the Brazilian pepper will allow District, Lee County Natural Resources and Parks and Recreation staff to design the best water quality and rehydration project for the preserve as part of the Four Corners Watershed Restoration Plan.

## 2. Objectives

The purpose of the project is to remove the Brazilian pepper monocultures on 12 acres of Daniels Preserve at Spanish Creek. Lee County Parks and Recreation staff will monitor the 12 acre project area and will treat resprouts of new Brazilian pepper plants once the Brazilian pepper monocultures have been removed. The Brazilian pepper removal will allow district and County Staff to better assess restoration plans in conjunction with the Four Corners Plan.

### 3. Scope of Work

This first phase of exotic plant removal is limited to Brazilian pepper removal on twelve acres (adjacent to the borrow pits and eastern fence line). The Brazilian pepper will be removed mechanically with heavy equipment. The pepper will be chipped and left on upland portions of the site.

Follow up handwork will consist of cutting invasive exotic shrub and tree stems, treating the stump with an appropriate herbicide. Restoration of the Daniels Preserve @ Spanish Creek is being conducted as a cooperative effort between the District, Lee County Parks and recreation and Lee County Natural resources. Completion of this Phase 1 exotic removal will facilitate design and permitting of the structural restoration tasks planned.

### 4. Work Breakdown Structure

Removal of exotics, re-treatment of exotics. Restoration work including exotic removal, re-treatment of exotics, and plantings will be completed. Deliverable: Letter from Lee County Parks and Recreation that work has been completed.

### 5. Lee County Parks and Recreation Responsibility

Lee County Parks and Recreation will be responsible for procuring the necessary services, Lee County will be responsible for project administration, oversight, permitting, and inspection through the successful completion of the entire project. Lee County will also be responsible for any operational maintenance after successful completion of the restoration project.

# 6. Payment and Deliverable Schedule

This is a cost-share project with funding coming from the following sources:

\$25,000 available from SFWMD

\$25,000 available from Lee County Parks & Natural Resources

\$50,000 Total Project Cost

The South Florida Water Management District's share will not exceed \$25,000.00.
