TITLE: Approve Amendment for Analytical Laboratory Services for Environmental Lab

I. MOTION REQUESTED

A) Approve Amendment No. 2 to the contract with Eurofins Environment Testing Southeast, LLC, under Solicitation No. B200307ANB, Analytical Laboratory Services, to add additional Environmental Protection Agency (EPA) water quality standards. The amendment will increase the contract amount by \$30,000.00 annually, with total anticipated expenditures in the amount of \$120,000.00.

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a contract amendment with Eurofins Environment Testing Southeast, LLC, under the solicitation for Analytical Laboratory Services, to add additional Environmental Protection Agency (EPA) water quality standards. The amendment will increase the contract amount by \$30,000.00 annually, with total anticipated expenditures in the amount of \$120,000.00. Total expenditures during Fiscal Year 2022-2023 were \$51,230. This increase is approved in the current year's fiscal budget.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On May 18, 2021, the Board of County Commissioners awarded B200307ANB, Analytical Laboratory Services, to TestAmerica Laboratories, Inc. dba Eurofins TestAmerica to provide analytical laboratory services for the Natural Resources Division to perform analyses that the Lee County Environmental Laboratory is not certified to perform or cannot perform due to equipment failure or natural disaster. The original term of the contract was for 3-years with an option to renew for up to 3 additional 1 year periods.

On April 1, 2022 Amendment No. 1 was administratively approved to assign the contract from the original entity name, TestAmerica Laboratories, Inc., dba Eurofins TestAmerica, to the new entity, Eurofins Environment Testing Southeast, LLC.
