

FIRST AMENDMENT OF THE AGREEMENT FOR APPAREL FOR LEE COUNTY

THIS FIRST AMENDMENT OF THE AGREEMENT FOR APPAREL FOR LEE COUNTY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Westview Corp., Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase silk screen services, embroidery services and apparel through Solicitation No. B210356MIF with Vendor on the 2nd day of February, 2022 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that a category of embroidery and silk screen services was erroneously left off of the Exhibit B. Fee Schedule of the Agreement; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Exhibit B. Fee Schedule of the Agreement to add the new category of services for embroidery and silk screen services to correct this error.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that Exhibit B Fee Schedule shall be superseded by the following:






