

FIRST AMENDMENT OF ANNUAL AGREEMENT
FOR SOFTBALL UMPIRE SERVICES

THIS FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR SOFTBALL UMPIRE SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Naples Referee and Umpire Association, ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of softball umpire services through Solicitation B180272RJD with Vendor on the 29th day of November, 2018 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the cost per game for purchasing the softball umpire services from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 20th day of November, 2021; and,

WHEREAS, the NCAA now requires bat testing at all baseball and softball tournaments; and,

WHEREAS, the Parties agree to add bat testing services to the scope of the Agreement; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN. IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following shall supersede Section 1.1. SCOPE OF WORK of the Scope of Work and Specifications in Exhibit A of the Agreement:

1.1 The Lee County Board of County Commissioners (BOCC) desires to obtain services from qualified firms to provide professional officiating services and bat testing services for baseball and/or softball tournaments and like events for the Lee County Parks and Recreation Department on an "as-needed" basis.

2. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:


