TITLE: Award Contract for Canal Cleaning Services and Drainage Restoration

I. MOTION REQUESTED

- A) Award Invitation to Bid No. B200252RJD, Canal Cleaning Services to Mohawk Valley Materials, Inc. for canal cleaning services and drainage restoration at various locations throughout the San Carlos Park area, in the amount of \$3,042,029.54.
- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners once the Department of Equal Opportunity has approved of the contract documents as well.

II. ITEM SUMMARY

Awards a contract to Mohawk Valley Materials, Inc. for canal cleaning services and drainage restoration at various locations throughout the San Carlos Park area, in the amount of \$3,042,029.54. Because of the extensive rainfall that occurred in August of 2017 and Hurricane Irma in September, several areas of the County experienced substantial flooding. One of the areas particularly hard hit was San Carlos Park. Because of that, the County requested and subsequently received a Community Development Block Grant (CDBG) for repairs to the sidewalks and drainage infrastructure. The grant will pay 100% of the cost of these repairs. The project is budgeted in the current fiscal year.

III. BACKGROUND AND IMPLICATIONS OF ACTION

- A) Board Action and Other History
 Procurement Management obtained bids for the project known as Invitation to Bid No. B200252RJD, Canal Cleaning Services. On the bid deadline of May 28, 2021, Procurement Management received three submittals. After conducting an analysis of the bid submissions, Mohawk Valley Materials, Inc. was determined to be the responsible bidder with the lowest responsive bid.

 Staff recommends awarding a contract to Mohawk Valley Materials, Inc. in the amount of \$3,042,029.54.

 Because of the extensive rainfall that occurred in August of 2017 and Hurricane Irma in September, several areas of the County experienced substantial flooding. One of the areas particularly hard hit was San Carlos Park. Because of that, the County requested and subsequently received a Community Development Block Grant (CDBG) in the amount of \$7,119,293 for repairs to the sidewalks and drainage infrastructure.

 On June 16, 2020, the Board accepted a grant from the State Department of Equal Opportunity (CDBG grant) in the amount of \$7,119,293.

 In 2017, the San Carlos Park area experienced flooding from the heavy rains in August and Hurricane Irma a month later. Subsequent to that, some improvements were made using FEMA and HMGP grant funds, but did not completely repair the drainage system. Because the area is considered low to moderate income, we applied for and received a CDBG grant to complete the work. The grant funds will be used to repair and upgrade the remaining drainage system as needed.

 Also awarded under the grant was repairs to the roadway drainage system and sidewalks within the area. DOT will bring award of this work to the Board as a separate agenda item.
