I. MOTION REQUESTED

A) Award Invitation to Bid No. B200418AEJ, Towing Services to the following vendors as either a primary or secondary vendor for towing and tire repair services on an as-needed basis, A Budget Towing, LLC and Alligator Towing & Transport, LLC, for an initial term of three years, as approved in the departments' annual adopted budgets.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

II. ITEM SUMMARY

Awards competitively solicited contracts to lowest responsive and responsible bidders, A Budget Towing, LLC as primary, and Alligator Towing & Transport, LLC, as secondary vendor for towing and tire repair services, on an as-needed basis, for an initial term of three years, as approved in the departments' annual adopted budgets. Towing services are typically required for an array of vehicles, trucks, buses, and equipment, as needed by Fleet Management, Solid Waste, LeeTran, Code Enforcement and other County departments. Expenditures for these services totaled approximately \$70,804.40 during Fiscal Year 2019-2020.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management obtained bids on behalf of the Board of County Commissioners for the project known as Invitation to Bid No. B200418AEJ Towing Services to fulfill the County's needs for towing and tire repair services. On the bid submission deadline of January 15, 2021, Procurement Management received two submittals. After conducting an analysis of the bid submissions, staff recommends award be made to the lowest responsive and responsible bidder in each category as follows:
