A) Approve Amendment No. 1 with Horseless Carriage Aficionado, LLC DBA Mighty Auto Parts, under Solicitation No. B210268LLP, Lubricant Products, to increase the price for the purchase of various lubricant products in accordance with the amended Fee Schedule.

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a contract amendment with Horseless Carriage Aficionado, LLC DBA Mighty Auto Parts, under the solicitation for Lubricant Products, to increase the price for the purchase of various lubricant products in accordance with the amended fee schedule. The price increase is due to increased market rates for these types of products and represents a total contract increase of up to 29.8% annually. Total expenditures during Fiscal Year 2021-2022 were approximately \$49,816.17 as of March 8, 2022.
