

FIRST AMENDMENT OF THE AGREEMENT FOR  
BOTTLED WATER PURCHASE AND DELIVERY

THIS FIRST AMENDMENT OF THE AGREEMENT FOR BOTTLED WATER PURCHASE AND DELIVERY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and BlueTriton Brands, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County executed an Agreement for the supply and delivery of bottled water, water-dispensing equipment, accessories, and servicing, through Solicitation B240103CFC with Vendor on the 5<sup>th</sup> day of April, 2024 ("Agreement");

WHEREAS, after the execution of the Agreement, it was discovered that it would be in the best interest of the County to add an additional unit of measure of 'Disposable Flat Bottom Drinking cups', item 4.1.7 of the Exhibit B. Fee Schedule of the Agreement, to allow the County to purchase a case of 9-ounce cups at a lower price than the current packs offered; and,

WHEREAS, adding this additional unit of measure of 9-ounce cups will result in an overall savings to the County when purchasing cups at this quantity; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the County and Vendor desire to enter into this First Amendment to modify the Exhibit B. Fee Schedule to add the additional product unit of measure for Item 4.1.7 - Disposable Flat Bottom Drinking cups' – 4 to 10 oz.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Fee Schedule shall supersede the existing Fee Schedule in Exhibit B of the Agreement:
