TITLE: Approve Contract Amendment for Purchase and Supply of Mulch - Countywide

### I. MOTION REQUESTED

A) Approve Amendment No. 1 to the contract with Express Mulch, Inc., under Solicitation No. B240126KCW, Purchase and Supply of Mulch – Annual, to add "Engineered Wood Fiber (EWF)," an additional blown in mulch product, to the Fee Schedule in Exhibit B of the Agreement. The amendment will increase the contract amount by an unknown amount annually, as it is an "as-needed" contract.

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

## II. ITEM SUMMARY

Approves a contract amendment with Express Mulch, Inc., under the solicitation for Purchase and Supply of Mulch – Annual, to add "Engineered Wood Fiber (EWF)," an additional blown in mulch product, to the Fee Schedule in Exhibit B of the Agreement. The amendment will increase the contract amount by an unknown amount annually, as it is an "as-needed" contract. Total expenditures during Fiscal Year 2022-2023 were \$86,189.90.

On April 16, 2024, the Board of County Commissioners awarded B240126KCW, Purchase and Supply of Mulch – Annual, to Express Mulch, Inc. and Forestry Resources LLC for the purchase and supply of mulch-related products on an as needed basis. The original term of the contract was for three years, with an option to renew for an additional two years. Express Mulch Inc. is the only awarded vendor that supplies blown in mulch products therefore an amendment is not required for the contract with Forestry Resources LLC.
